

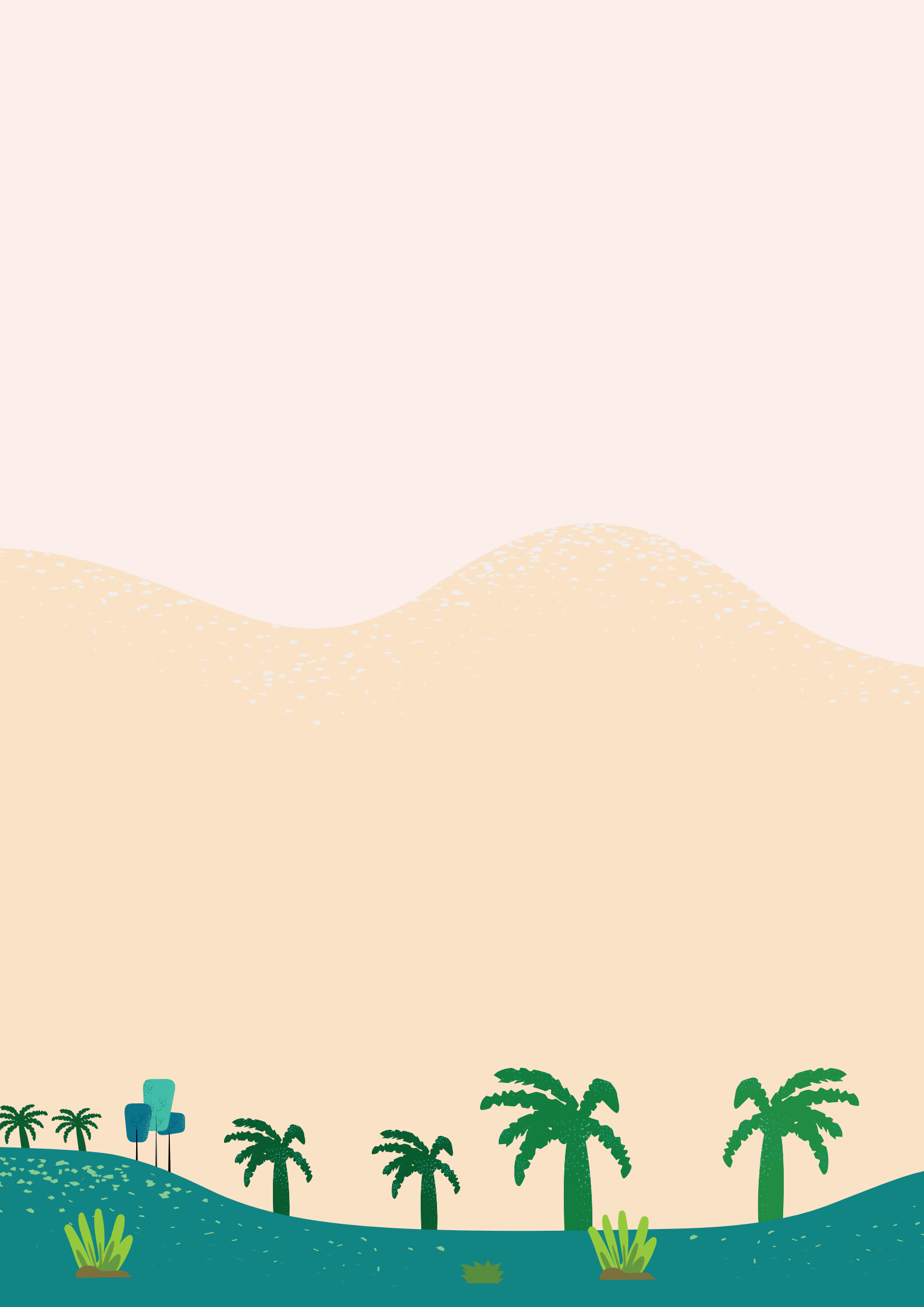

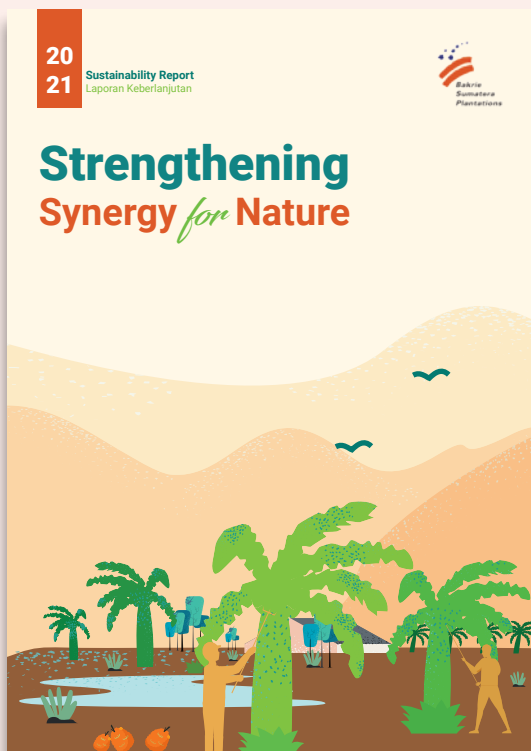

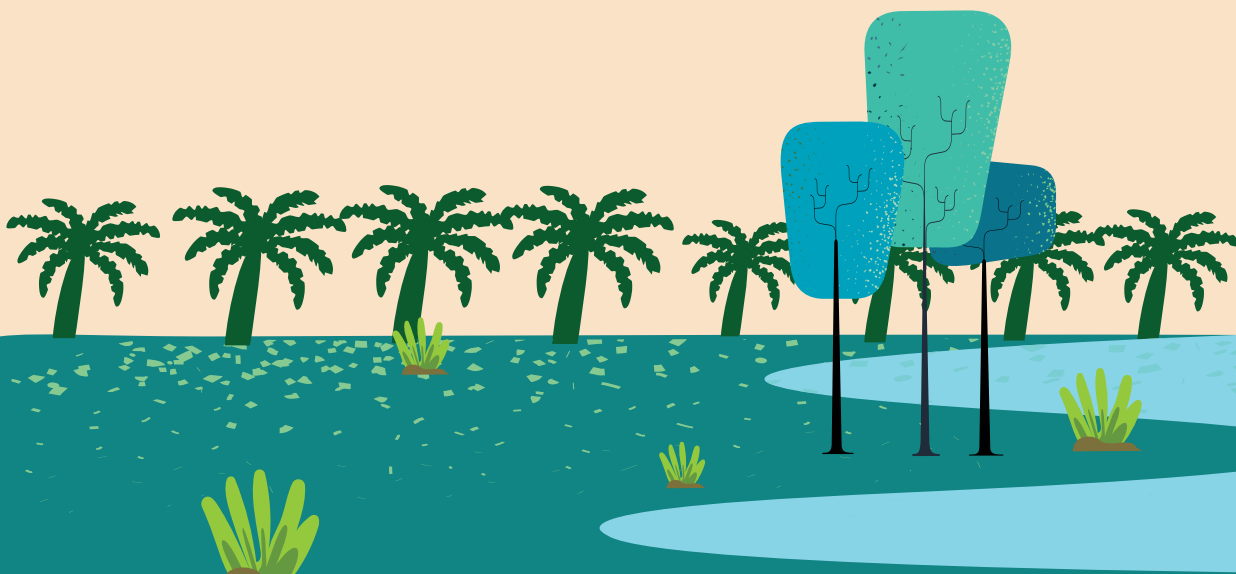




Penjelasan Tema Theme Explanation

Sejalan dengan tema Laporan Tahunan 2021 BSP yakni Perseroan berhasil bangkit dari sisi ekonomi dengan membukukan penghasilan neto positif. Tema Laporan Keberlanjutan mencoba untuk menyampaikan bahwa keberhasilan BSP dapat terjadi karena Perseroan juga memperkuat sinergi dan strategi dari sisi keberlanjutan. Tema ini juga menjelaskan bentuk tanggung jawab Perseroan untuk menyampaikan bahwa kegiatan bisnis yang dijalankan BSP tetap menerapkan kebijakan sustainable palm oil yang berlaku baik secara nasional maupun internasional dengan inovasi yang dikembangkan untuk mendukung keseimbangan lingkungan, sosial dan tata kelola yang baik.

The Company is always committed to carrying out all operational activities per the Company’s Vision, Mission, and Core Values by prioritizing sustainability principles as outlined in the Sustainability Commitment and Policy. This Sustainability Commitment and Policy is formulated into “BSP”, an abbreviation of Benefit, Social and Planet, as the basis for our Sustainability Commitment and adopts “NDPE”, an abbreviation of No Deforestation No Peat No Exploitation and Transparency, as the basis of the Sustainability Policy. Both are realized with innovations developed to support a balance of economic, social, environmental, and good governance performance while still referring to regulations and standards that apply at the local and global levels.

In 2021, the Company carried the theme “**Strengthening Synergy to Nature**” as the realization of this commitment, to explain that the Company earned its success by strengthening our sustainability synergy and strategy.



Kebijakan untuk Merespon Tantangan

Policy for Responding the Challenges

Pada tahun 2021, pandemi COVID-19 memasuki tahun ketiga. Perseroan masih menerapkan produktivitas berkelanjutan sebagai kebijakan strategis yang telah ditetapkan, dengan fokus pada upaya peningkatan produktivitas lahan, peningkatan kualitas hasil lahan, serta optimalisasi pendayagunaan fasilitas pengolahan dan fasilitas pendukung lainnya.

Perseroan juga memberikan perhatian khusus pada produksi dan penggunaan benih unggul sawit untuk meningkatkan produktivitas kebun inti dan lahan plasma, sejalan dengan proses peremajaan tanaman (replanting) yang saat ini masih berada pada tahap awal program jangka panjang. Perseroan menggunakan benih unggul yang telah dikembangkan di fasilitas pembibitan Seed Garden, bekerja sama dengan ASD Costa Rica. Benih unggul ini memungkinkan peningkatan produktivitas kebun sawit tanpa adanya ekspansi lahan, dan mampu mencapai 38-40 ton per hektar dan tingkat ekstraksi *Crude Palm Oil* (CPO) mencapai sekitar 25%. Selain itu Perseroan juga melanjutkan kebijakan proses pengembangan fungsi lahan karet terkait tanaman karet yang sudah melampaui usia produktif.

In 2021, the COVID-19 pandemic entered its third year. The Company still implements sustainable productivity as a predetermined strategic policy, focusing on efforts to increase land productivity, increase the quality of land products, and optimize the utilization of processing facilities and other supporting facilities.

The Company also pays special attention to the production and use of superior oil palm seeds to increase the productivity of its nucleus estates and plasma land, in line with the replanting process, which is currently still in the early stages of its long-term program. The Company uses superior seeds developed at the Seed Garden nursery facility in collaboration with ASD Costa Rica. These superior seeds allow for increased productivity of oil palm plantations without land expansion and can reach 38-40 tons per hectare, and Crude Palm Oil (CPO) extraction rates reach around 25%. In addition, the Company continues developing the function of rubber land related to rubber plantations that have exceeded their productive age.

Penerapan Kinerja Keberlanjutan

Implementation of Sustainability

Benefit

Pada tahun 2021 Perseroan berhasil membukukan laba neto sebesar Rp 128,7 miliar. Laba neto mengalami pertumbuhan 116,75% dibandingkan tahun 2020 yang mencatat rugi neto sebesar Rp 768,3 miliar. Perseroan juga mencatat penjualan neto sebesar Rp 3,9 triliun atau 18,61% lebih tinggi dari target. Penjualan neto juga mengalami pertumbuhan 58,42% dibandingkan tahun 2020 yang sebesar Rp 2,5 triliun.

Perseroan terus memaksimalkan dampak positif dengan melaksanakan digitalisasi dalam proses bisnisnya dalam rangka meningkatkan pengendalian internal untuk mencapai efektivitas dan efisiensi operasi melalui penerapan *Enterprise Resource Planning* (ERP) dan *Whistleblowing System* (WBS).

Benefit

In 2021 the Company managed to record a net profit of IDR 128.7 billion. Net profit experienced a growth of 116.75% compared to 2020 which recorded a net loss of IDR 768.3 billion. The company also recorded net sales of IDR 3.9 trillion or 18.61% higher than the target. Net sales also grew by 58.42% compared to 2020 which amounted to IDR 2.5 trillion.

The Company continues to maximize the positive impact by implementing digitization in its business processes in order to improve internal control to achieve operational effectiveness and efficiency through the implementation of *Enterprise Resource Planning* (ERP) and a *Whistleblowing System* (WBS).



Perencanaan proses implementasi ERP dilakukan Perseroan melalui kegiatan standarisasi proses bisnis dengan nama program “*System & Process Improvement*” dan dilanjutkan dengan implementasi ERP mulai dari proses *Field Operation*, *Back Office* dan *Financials*.

Planning for the ERP implementation process is carried out by the Company through business process standardization activities under the name of the “*System & Process Improvement*” program and continued with ERP implementation starting from the *Field Operation*, *Back Office*, and *Financials* processes.

Dalam upaya peningkatan Tata Kelola dan Anti Korupsi, pada tahun 2021 Perseroan telah menyelesaikan pengembangan aplikasi Whistleblowing System (WBS) yaitu sebuah mekanisme yang disediakan oleh Perseroan bagi pihak terkait untuk menyampaikan informasi atau laporan indikasi pelanggaran oleh segenap tingkatan pegawai dan jajaran manajemen. Secara berkelanjutan, Perseroan juga senantiasa melakukan pemutakhiran dan sosialisasi atas dokumen Pakta Integritas (*integrity pact*) dan Pedoman Perilaku (*code of conduct*) sebagai landasan komitmen yang menjunjung nilai-nilai etika dalam bekerja oleh segenap karyawan.

In an effort to improve Governance and Anti-Corruption implementation in 2021 the Company has completed the development of the Whistleblowing System (WBS) application, which is a mechanism provided by the Company for related parties to submit information or report indications of violations by all levels of employees and management. On an ongoing basis, the Company also regularly updates and socializes the integrity pact and code of conduct as a basis for commitment to upholding ethical values at work by all employees.

Social

Salah satu nilai inti sebagai dasar pengembangan budaya Perseroan adalah “BISA”, singkatan dari: BSP Rumah Kita (B), Inisiatif dan Pemberdayaan yang Bertanggung jawab (I), Semangat Membawa Misi (S), Adaptabilitas terhadap Perubahan dan Kemampuan Menciptakan Kemajuan (A). Untuk mewujudkan nilai tersebut, Perseroan berkomitmen untuk mewujudkan pemberdayaan, kesejahteraan, keselamatan dan kesehatan kerja bagi pekerja dan masyarakat melalui indikator keberhasilan kinerja yang telah ditetapkan.

Social

One of the core values as the basis for the development of the Company’s culture is “BISA”, an abbreviation of: BSP Rumah Kita (B), Responsible Initiative and Empowerment (I), Passion for Carrying Mission (S), Adaptability to Change and Ability to Create Progress (A). To realize this value, the Company is committed to realizing empowerment, welfare, occupational safety, and health for workers and the community through predetermined performance success indicators.



Selain itu, Perseroan mendukung penuh upaya Pemerintah untuk memutus rantai penyebaran COVID-19 dengan berbagai tindakan yang bersifat pencegahan dan pengendalian. Perseroan melaksanakan sosialisasi berkala pencegahan COVID-19, menerapkan protokol kesehatan secara ketat, pembatasan kegiatan, dukungan penuh pengobatan bagi karyawan beserta keluarga karyawan yang terdampak dan melakukan program vaksinasi COVID-19 untuk karyawan beserta keluarga dan masyarakat sekitar.

Untuk mendukung masyarakat yang lebih mandiri, secara berkelanjutan Perseroan telah melaksanakan kegiatan pemberdayaan dengan fokus pengembangan pada sembilan bidang yakni pendidikan, ekonomi, kesehatan, keagamaan, kepemudaan, lingkungan, infrastruktur, tanggap bencana serta donasi/publikasi. Total realisasi anggaran program pemberdayaan masyarakat tahun 2021 sebesar Rp 7.3 Miliar.

Planet

Hingga akhir tahun 2021, Perseroan mengelola lahan seluas 31.141 Ha yang telah tersertifikasi ISPO dan 19.117 Ha yang tersertifikasi RSPO. Perseroan melestarikan keanekaragaman hayati dengan mengalokasikan lahan seluas 63,45 Ha sebagai area konservasi flora dan fauna langka, area penyerapan air, serta kawasan pendidikan. Selain mengembangkan dan menjaga areal konservasi yang sebelumnya sudah kaya akan keanekaragaman hayati, Perseroan juga melakukan identifikasi dan pemantauan secara berkala atas kawasan bernilai konservasi tinggi (*High Conservation Value* - HCV).

Perseroan juga berkomitmen dalam mencegah kebakaran hutan dan lahan (karhutla). Upaya yang dilakukan, antara lain melalui kerja sama multipihak untuk memperkuat kolaborasi dalam mengimplementasikan program-program pencegahan kebakaran, pemenuhan sumberdaya (SDM, sistem kerja, sarana dan prasarana serta kompetensi) dan upaya pencegahan terpadu dalam bentuk sistem peringatan dan deteksi dini.

Perseroan juga turut berkontribusi dalam upaya pengendalian perubahan iklim. Pada tahun 2021, total emisi GRK yang dihasilkan Perseroan adalah 27.710,11 Ton CO₂eq, naik/turun 1,03% dibandingkan tahun 2020. Sementara itu, jumlah penggunaan energi adalah sebesar 111.988 Gj.

In addition, the Company fully supports the Government's efforts to break the chain of transmission of COVID-19 with various preventive and control measures. The Company carries out regular socialization on prevention of COVID-19, implements strict health protocols, limits activities, provides full medical support for employees and their families who are affected and conducts a COVID-19 vaccination program for employees and their families and the surrounding community.

To support a more independent community, the Company has carried out empowerment activities on an ongoing basis with a focus on development in nine areas, namely education, economy, health, religion, youth, environment, infrastructure, disaster response and donations/publications. The total realized budget for the community empowerment program in 2021 is IDR 7,3 billion.

Planet

Until the end of 2021, the Company manages 31,141 Ha of land which has been ISPO certified, and 19,117 Ha which is RSPO certified. The Company conserves biodiversity by allocating 63.45 hectares of land as a conservation area for rare flora and fauna, a water absorption area, and an educational area. In addition to developing and maintaining conservation areas that were previously rich in biodiversity, the Company also conducts periodic identification and monitoring of high conservation value (HCV) areas.

The Company is also committed to preventing forest and land fires (Karhutla). Efforts are made, among others, through multi-stakeholder cooperation to strengthen collaboration in implementing fire prevention programs, fulfillment of resources (HR, work systems, facilities and infrastructure, and competence), and integrated prevention efforts in the form of warning systems and early detection.

The Company also contributes to efforts to control climate change. In 2021, the total GHG emissions produced by the Company are 27,710.11 tons of CO₂eq, up/down 1.03% compared to 2020. Meanwhile, total energy use is 111,988 Gj.



Strategi Mencapai Target Strategy to Reach the Target

Perumusan target dan strategi dilaksanakan dengan memperhatikan kondisi pasar global dan kebijakan Pemerintah. Peran sawit sebagai sumber energi terbarukan terus meningkat dan menjadi peluang bagi BSP.

Pemerintah menerapkan program mandatori biodiesel B30 (campuran 30% *fatty acid methyl ester*/FAME dengan 70% bahan bakar solar). Selanjutnya, Pemerintah menargetkan penggunaan biodiesel B40, dimulai pada Oktober 2022.

Selain itu, Pemerintah juga berkomitmen untuk melakukan peremajaan (*replanting*) seluas 180 ribu hektar kebun kelapa sawit milik petani dengan penggunaan benih unggul. Hal ini menjadi prospek usaha yang positif bagi Perseroan, sejalan dengan strategi pemanfaatan benih unggul. Diharapkan semua strategi ini menjadi langkah efektif untuk mencapai target kinerja keberlanjutan.

The formulation of targets and strategies is carried out by taking into account global market conditions and government policies. The role of oil palm as a source of renewable energy continues to increase and is an opportunity for BSP.

The Government implements a mandatory B30 biodiesel program (a mixture of 30% fatty acid methyl ester/FAME with 70% diesel fuel). Furthermore, the Government is targeting the use of B40 biodiesel, starting in October 2022.

In addition, the Government is also committed to replanting 180 thousand hectares of oil palm plantations owned by farmers using superior seeds. This is a positive business prospect for the Company, in line with the strategy of utilizing superior seeds. It is hoped that all of these strategies will become effective steps to achieve sustainability performance targets.

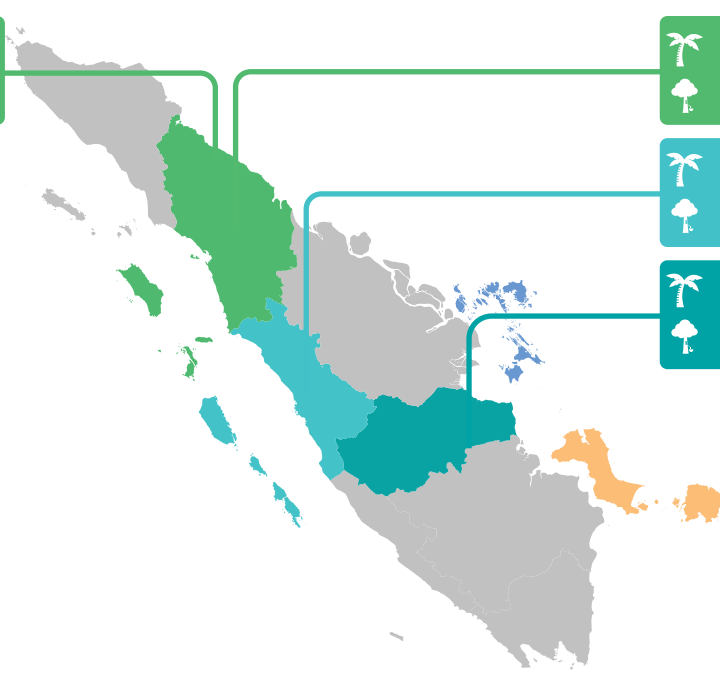

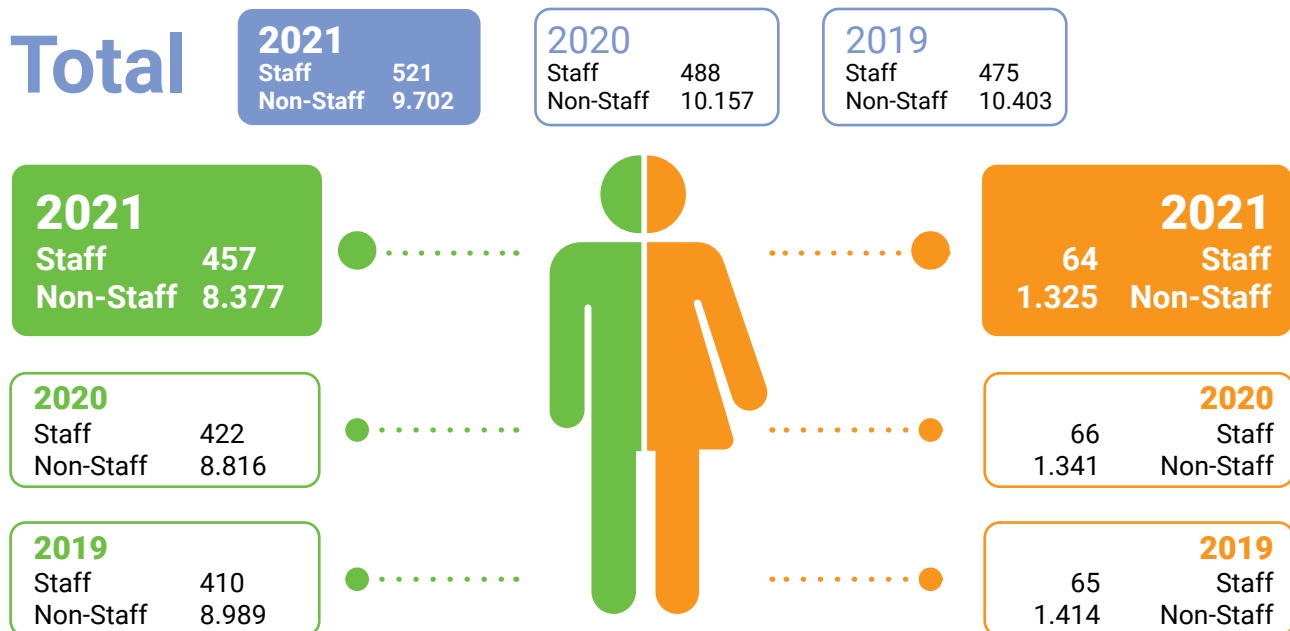

Kegiatan Usaha dan Rantai Pasokan [102-2, 102-6, 102-9] Business Activity and Supply Chain

Segmen usaha Perseroan terdiri dari sawit, oleokimia, dan karet. Produksi dari segmen usaha sawit terdiri dari minyak sawit (CPO), inti sawit (PK), dan minyak inti sawit (PKO) yang ditargetkan untuk domestik. Sementara itu, dari segmen oleokimia meliputi pengolahan produk *fatty acid*, *fatty alcohol* dan *glycerin* yang ditargetkan untuk permintaan pasar bebas. Perseroan juga memiliki pabrik penyulingan yang dapat memproduksi *olein*, *stearin* dan *palm fatty acid distillate* (PFAD). Pada segmen karet, Perseroan memproduksi rangkaian lengkap produk karet alam, mulai dari *lateks* sampai *block skim rubber* (BSR), dengan pasar yang terlayani sebanyak 75,27% pasar domestik, dan 24,73% ekspor.

The Company's business segments consist of palm oil, oleochemicals, and rubber. Production from the palm oil business segment comprises of crude palm oil (CPO), palm kernel (PK), and palm kernel oil (PKO) which are targeted for domestic use. Meanwhile, the oleochemicals segment comprises of the processing of fatty acids, fatty alcohols and glycerin targeted for free market demand. The company also has a refinery that can produce olein, stearin and palm fatty acid distillate (PFAD). In the rubber segment, the Company produces a complete set of natural rubber products, ranging from latex to block skim rubber (BSR), with 75.27% of which served the domestic market and the 24.73% for exports.



Oleokimia adalah produk kimia berbasis sumber terbarukan dari minyak nabati dan lemak hewani yang menjadi produk alternatif petrokimia. CPO dan PKO adalah alternatif bahan baku yang umum digunakan untuk diolah menjadi produk turunan oleokimia, seperti margarin, es krim, sabun, bahan bakar, deterjen, dan sebagainya.

Oleochemicals are chemical products based on renewable sources from vegetable oils and animal fats as alternatives of petrochemical products. CPO and PKO are alternative raw materials which are commonly used to be processed into oleochemical derivative products, such as margarines, ice creams, soaps, fuels, detergents, etc.

Perseroan mendefinisikan lokal sebagai penduduk setempat atau penduduk yang sudah lama menetap di sekitar wilayah operasional Perseroan. The Company realizes that our business activities can have an impact on the local community. The company prioritizes local suppliers and workers. The company defines locals as the community or residents around the BSP operational area. Supply chain management from upstream to downstream is the responsibility of the Operations (plantations and factories) and Support (Procurement and Commerce) Departments which are coordinated by the QHSE & Sustainability Department. Evaluation and monitoring of supply chain activities is carried out regularly and is reported to the Company's Board of Directors.

CPO, PK, dan PKO dihasilkan dari pasokan Tandan Buah Segar (TBS) berasal dari kebun inti, kebun plasma, serta pembelian dari pemasok lokal. Sementara itu, karet dihasilkan dari getah karet berasal dari kebun milik Perseroan (inti) dan pembelian dari pihak ketiga/pemasok lokal. CPO, PK and PKO are produced from supplies of Fresh Fruit Bunches (FFB) of nucleus estates, plasma estates, as well as purchases from local suppliers. Meanwhile, rubber is produced from natural rubber latex originating from the Company's nucleus estates as well as purchases from third parties/local suppliers. In 2021, the realized contract value of raw material procurements for local suppliers reached IDR 2 trillion or 67% of the total procurement value.

Kebijakan ini bertujuan untuk mendorong perubahan yang dibutuhkan dalam rantai pasokan kelapa sawit Perseroan yang berlaku untuk semua minyak kelapa sawit yang dibeli oleh Perusahaan, termasuk TBS, minyak sawit mentah, inti sawit, minyak inti sawit dan turunannya. Kebijakan ini berlaku di seluruh kegiatan operasional Perusahaan dan untuk semua pemasok dan seluruh kegiatan operasi mereka, termasuk pedagang dan pihak ketiga mereka.

Perseroan mensyaratkan pemasok untuk menaati Kebijakan Pengadaan Minyak Kelapa Sawit Berkelanjutan. Perseroan berkomitmen untuk melakukan keterlacakan hingga 100% untuk semua minyak sawit mentah dan turunannya yang dibeli Perseroan serta melakukan penilaian risiko lingkungan dan sosial atas setiap pasokan bahan bakunya. Selain itu, untuk pemasok yang sumbernya dianggap berisiko tinggi, Perseroan mewajibkan pemasok untuk memberikan verifikasi pihak ketiga yang independen bahwa minyak sawit yang dipasok sesuai dengan Kebijakan Minyak Kelapa Sawit Berkelanjutan Perseroan.

This policy aims to support the necessary transformation in the Company's palm oil supply chain which applies to all palm oil purchases of the Company, including FFBs, crude palm oils, palm kernels, palm kernel oils, and their derivatives. This policy applies throughout the Company's operational activities as well as all suppliers and their entire operations, including their third parties and traders.

The Company requires suppliers to comply with the Sustainable Palm Oil Procurement Policy. The Company is committed to carrying out up to 100% traceability of all crude palm oil and its derivatives purchased by the Company as well as conducting environmental and social risk assessments for each supply source of raw materials. In addition, for suppliers whose sourcing is considered at high risk, the Company requires them to provide independent third party verification in that the palm oil supplied is in accordance with the Company's Sustainable Palm Oil Policy.

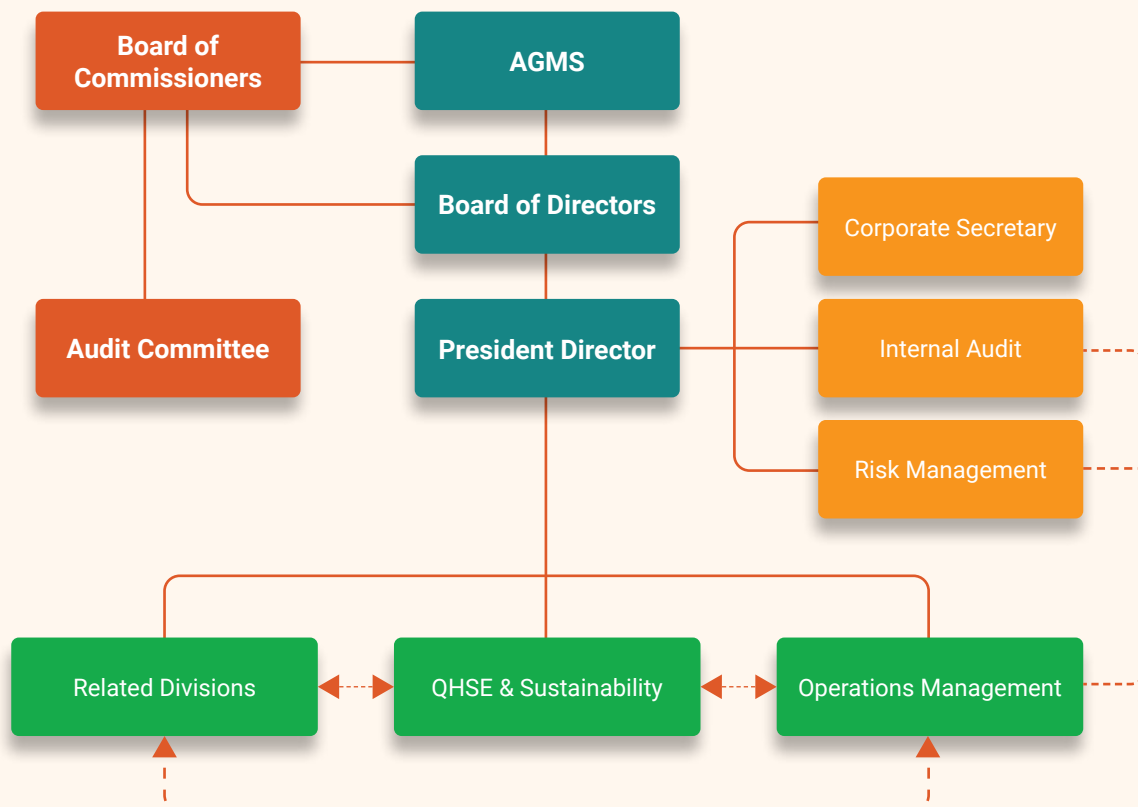

The structure of the Company's sustainability governance is guided by Law no. 40/2007 concerning Limited Liability Companies, consisting of the General Meeting of Shareholders (GMS), the Board of Commissioners which has supporting committees namely the Audit Committee and the Nomination and Remuneration Committee, Directors, Corporate Secretary and Internal Audit and Risk Management. Implementation of sustainability governance is carried out collectively by each function. Information regarding the organizational structure, duties and responsibilities of the Company's Board of Commissioners and Directors can be seen in the Annual Report.

The Company has implemented a Corporate Risks Management System (SMR). Implementation activities of this System were carried out in the form of:

1. Operational risks evaluation (plantations, mills, and supporting functions);
2. Project risks evaluation;
3. Initiation of the establishment of quality risks, environmental risks, and OHS risks evaluation work guidelines, with reference to ISO standards for quality, environment, and risk based OHS;
4. Competency development for risk analysts;
5. Improvement of internal business processes includes preparing annual work plans and budgets, updating SMR work guidelines as well as performance evaluations.

In the risk evaluation process, all events which potentially hinder the accomplishment of the Company's goals are subject to a process of risks identification, assessment, and mitigation on a regular basis. The results of the risks assessment are in the form of a Company's Risk Profile. Further information regarding the Company's Risk Profile is presented in the Annual Report of 2021.

Digitalisasi

Digitization

Pada tahun 2021, Perseroan melakukan beberapa program digitalisasi dalam proses bisnisnya dalam rangka meningkatkan pengendalian internal untuk mencapai efektivitas dan efisiensi operasi melalui penerapan *Enterprise Resource Planning* (ERP) dan *Whistleblowing System* (WBS).

Perencanaan proses implementasi ERP telah dilakukan Perseroan melalui kegiatan standarisasi proses bisnis dengan nama program "*System & Process Improvement*", setelah itu dilanjutkan dengan implementasi ERP mulai dari proses *Field Operation*, *Back Office* dan *Financials*. Pelaksanaan implementasi ERP dilakukan dengan menggunakan metode *Pilot Project* yang kemudian dilanjutkan dengan *Roll Out* ke Unit Usaha lainnya. ERP dirancang untuk memberikan informasi yang akurat dan memadai terkait kinerja Perseroan, serta merupakan infrastruktur bagi peningkatan efektivitas dan efisiensi proses pengendalian dan pengawasan internal.

In 2021, the Company carried out several digitization programs within our business processes in order to improve internal control in achieving operational effectiveness and efficiency through the implementation of *Enterprise Resource Planning* (ERP) and *Whistleblowing System* (WBS).

Planning for the ERP implementation process has been carried out by the Company through business process standardization activities under the name of the "*System & Process Improvement*" program, after which it is continued with ERP implementation starting from the *Field Operation*, *Back Office* and *Financials* processes. Implementation of ERP implementation is carried out using the *Pilot Project* method which is then followed by a *Roll Out* to other Business Units. ERP is designed to provide accurate and adequate information regarding the Company's performance, as well as being an infrastructure for increasing the effectiveness and efficiency of internal control and supervision processes.



Perseroan telah menyelesaikan pengembangan aplikasi Whistleblowing System (WBS), dilanjutkan dengan proses sosialisasi dan penerapan awal atas implementasi WBS. WBS merupakan mekanisme yang disediakan oleh Perseroan bagi pihak terkait untuk menyampaikan informasi atau laporan indikasi pelanggaran oleh segenap tingkatan pegawai dan jajaran manajemen yang terjadi di lingkungan Perusahaan. Aplikasi WBS menggunakan mekanisme enkripsi untuk proteksi data sehingga dapat menjamin kerahasiaan data identitas pengguna. Selain itu, mekanisme enkripsi memberikan kemudahan dalam melacak perkembangan proses laporan.

The Company has finalized the development of the Whistleblowing System (WBS) application, followed by the dissemination and initial process of the WBS implementation. WBS is a mechanism provided by the Company for related parties to disclose information or reports on indications of committed violations by all levels of employees and management within the Company. The WBS application uses an encryption mechanism for data protection to guarantee the data confidentiality of users' identity. In addition, the encryption mechanism makes it easy to track the reporting process.

On an ongoing basis, the Company's Code of Conduct is always updated, disseminated, and published through our digital information system "BSP Portal" and the Company's website which can be accessed by all employees and other stakeholders.

Kinerja ekonomi menggambarkan kontribusi Perseroan dalam menerapkan strategi bisnis berkelanjutan, baik langsung maupun tidak langsung. Pengelolaan kinerja ekonomi mengacu kepada regulasi dan peraturan yang berlaku. Kinerja ekonomi menjadi tanggung jawab Divisi Operasional dan Support (Commerce dan Finance). Evaluasi dan pemantauan kinerja ekonomi dilakukan secara berkala oleh Divisi Corporate Finance dan Corporate Internal Audit serta dilaporkan kepada Direksi dan pihak-pihak terkait. Dalam RUPS Tahunan, kinerja ekonomi dan kinerja Perseroan akan disampaikan kepada pemegang saham.

Pada tahun 2021, Perseroan berhasil membukukan penjualan neto sebesar Rp3,9 triliun miliar atau 119% dari target. Penjualan oleokimia menjadi penyumbang terbesar penjualan Perseroan, yaitu 46,25%. Selama tahun 2021, Perseroan menerima bantuan finansial dari Pemerintah berupa fasilitas penurunan tarif Pajak Penghasilan (PPh) Badan yang disebabkan adanya pandemi COVID-19, hal ini merujuk kepada Peraturan Pemerintah No. 1/2020 terkait kebijakan keuangan negara dan stabilitas sistem keuangan untuk penanganan pandemi Coronavirus Disease ("COVID-19").

Economic performance elucidates the Company's contribution in implementing sustainable business strategies, both directly and indirectly. The management of economic performance refers to the applicable rules and regulations. Economic performance is the responsibility of the Operational Division and Support (Commerce and Finance). Evaluation and monitoring of economic performance is carried out regularly by the Corporate Finance Division and Corporate Internal Audit Division for reported to the Board of Directors as well as to related parties. In the Annual General Meeting of Shareholders, the economic performance and the Company performance as a whole will be presented to shareholders.

In 2021, we managed to record net sales of IDR 3.9 trillion or 119% of the target. Sales of oleochemicals became the largest contributor to the Company's sales, which was 46.25%. During 2021, the Company received financial assistance from the Government in the form of income tax rate relief according to Government Regulation No.1/2020 concerning the State Financial Policies and Financial System Stability for Handling the Corona Virus Disease (COVID-19) Pandemic.

In addition, the Company has also obtained certifications related to quality, environmental and social management, such as the Indonesian Sustainable Palm Oil (ISPO), Roundtable on Sustainable Palm Oil (RSPO), ISO 9001:2015, ISO 14001:2015, SMK3, SPPT SNI (SIR and RSS), ISO 22000:2018, HACCP, GMP and GMP +B2, Halal Assurance and Kosher certificate, as well as the Food and Drug Administration (FDA) certificate. Inovasi dan Pengembangan Produk

Product Innovation and Development

Pada tahun 2021, Perseroan telah melaksanakan proses inovasi dan pengembangan produk dalam lingkup kebun dan pabrik.

Dalam pengembangan teknik perkebunan maupun pengolahan komoditi karet, melalui dukungan fasilitas Bakrie Agricultural Research Institute (BARI), Perseroan telah menerapkan teknik penjadapan getah karet upward tapping yang dapat meningkatkan produktivitas. Perseroan juga telah melakukan kerjasama dengan lembaga riset agronomi internasional untuk menghasilkan terobosan-terobosan baru di bidang teknologi guna meningkatkan nutrisi tanaman karet, aplikasi pemupukan, manajemen perkebunan, serta pelestarian lingkungan.

Perseroan bersama ASD-Costa Rica telah mengembangkan fasilitas pembibitan Seed Garden berlokasi di Kisaran, Sumatera Utara. Dari kerjasama ini telah dihasilkan sejumlah bibit unggul kelapa sawit, seperti DxP Themba, DxP Spring, DxP CR Supreme dan DxP CR Ovane, dengan ekspektasi usia tanaman sampai 30 tahun serta potensi produktivitas hingga mencapai 40 ton TBS per hektar, lebih tinggi dari bibit biasa yang menghasilkan 25-30 ton TBS per hektar.

Terkait pengelolaan pabrik, Perseroan telah melakukan revitalisasi dan peningkatan kapasitas pabrik kelapa sawit di Unit Usaha Sumut 2 (GLP). Selain itu, dalam upaya meningkatkan fasilitas penunjang dan infrastruktur pengolahan oleokimia, Perseroan saat ini menggunakan teknologi terbaik dalam industri terkait antara lain Lurgi Technology (Jerman) untuk Fatty Acid Plant dan Fatty Alcohol Plant; serta JJ Lurgi Engineering untuk Palm Oil Refinery. Hasil produksi dari fasilitas pengolahan oleokimia Perseroan digunakan sebagai bahan baku bagi produsen Fast Moving Consumer Goods (FMCG). Perseroan melanjutkan proses upgrade untuk pabrik pengolahan inti sawit yang saat ini dalam tahap produksi non-komersial. Selain itu, Perseroan juga melakukan proses peningkatan utilisasi kapasitas fasilitas pengolahan Line 1 (*Fatty Acid Plant 1* dan *Fatty Alcohol Plant 1*) dan mempersiapkan penyelesaian fasilitas Line 2 (*Fatty Acid Plant 2* dan *Fatty Alcohol Plant 2*).

In 2021, the Company has performed product development and innovation processes within the plantations and factories scope.

In the development of plantation techniques as well as the processing of rubber commodities, through the support of the Bakrie Agricultural Research Institute (BARI) facilities, the Company has implemented upward tapping techniques for tapping rubber sap which can increase productivity. The company has also collaborated with international agronomic research institutes in inventing new breakthroughs in technologies to improve rubber plants nutrition, fertilization applications, plantations management, as well as environmental preservation.

The Company together with ASD-Costa Rica have developed a Seed Garden nursery facility located in Kisaran, North Sumatra. This collaboration has resulted in a number of high-yielding oil palm seeds, such as DxP Themba, DxP Spring, DxP CR Supreme and DxP CR Ovane, with expected plant age of up to 30 years and potential productivity of up to 40 tonnes of FFB per hectare, which is higher than ordinary seeds that produce 25-30 tonnes of FFB per hectare.

On factories management, the Company has revitalized and improved the capacity of the palm oil mills in the Sumut 2 (GLP) Business Unit. In addition, in an effort to develop supporting facilities and infrastructures for oleochemicals processing, the Company is currently using the best technology in related industries, for example the Lurgi Technology (Germany) for Fatty Acid Plants as well as for Fatty Alcohol Plants; and the JJ Lurgi Engineering for Palm Oil Refineries. Production results from the Company's oleochemicals processing facilities are used as raw materials by Fast Moving Consumer Goods (FMCG) producers. The company is continuing the upgrade process for the palm kernel processing plants which is currently in the non-commercial production stage. In addition, the Company is also carrying out the process of improving the capacity utilization in the Line 1 processing facilities (*Fatty Acid Plant 1* and *Fatty Alcohol Plant 1*) as well as preparing for the finalization of the Line 2 facilities (*Fatty Acid Plant 2* and *Fatty Alcohol Plant 2*).

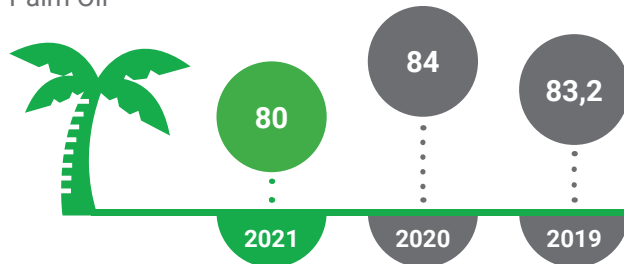

Average Score of Customer Satisfaction Survey

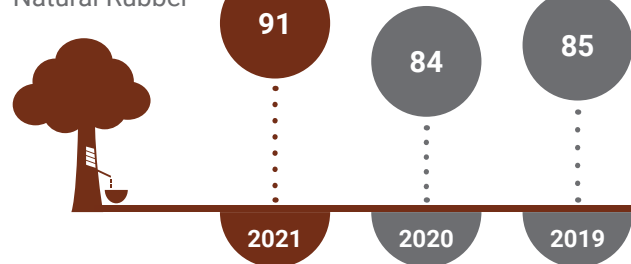

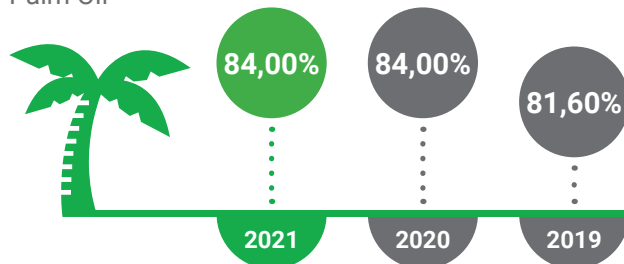


Rata-rata Customer Satisfaction Index Karet (CSI)

Average of Customer Satisfaction Index

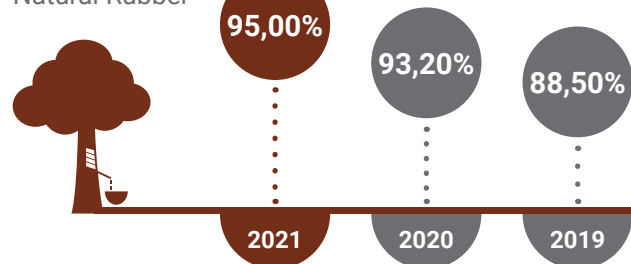

Sementara itu, terdapat keluhan terkait mutu dari konsumen produk sawit yang disebabkan oleh gangguan proses produksi di pabrik. Perseroan telah melakukan mitigasi berupa pengadaan dan pemeliharaan berkala atas mesin produksi, peningkatan kompetensi petugas operasional dan pemantauan, inspeksi dan tinjauan berkala.

The Company provides access for consumers to submit any complaint related with our products and services. Consumer complaints can be submitted via email. The management of consumer complaints is the responsibility of the Commerce Division. In 2021, there were no complaints from consumers regarding the rubber products. Meanwhile, there were complaints regarding the quality of palm products due to disruptions in the production process at the factory. The Company has performed mitigations in the form of regular procurement and maintenance of production machineries, improving the competency of operational and monitoring staff, as well as periodic inspections and reviews.

Selama tahun 2021, Perseroan mendapatkan Penghargaan Kecelakaan Kerja Nihil (*Zero Accident Award*) dari Kementerian Ketenagakerjaan Republik Indonesia serta Penghargaan atas Pencegahan dan Penanggulangan COVID-19 di Tempat Kerja Kategori Silver dari Gubernur Sumatera Barat.

The Company realizes that all parties involved in the Company's operational activities is directly or indirectly contributing to the accomplishment of the Company's vision and mission. The Company strives to develop a convenient feeling like at home, a strong sense of belonging, an always upholding teamwork, mutual respect, open communication, a company care as if own home, tolerance, and an endeavor for harmony towards the same direction. Therefore, the Company implements SMK3 which refers to the Government Regulation No. 50 of 2012. The Company provide facilities in the plantations and factory areas in the form of a clinic and integrated health service (Posyandu), as well as the General Public Hospital Ibu Kartini which is also open to the local community. The Company conducts routine medical check-ups (MCU) for all employees. During 2021, there were 980 employees who have undertaken MCU. Based on the MCU, the dominant Occupational Diseases as recorded Suspect NIHL (Noise Induced Hearing Loss), Mild Restriction, Mild Obstruction, Mild Toxicity etc. . In addition, the Company also enrolled all employees in the Jaminan Kesehatan Nasional (JKN) program administered by BPJS Kesehatan. The Company provides support for medical expenses for staff class employees through a medical reimbursement mechanism.

Perseroan menghormati hak asasi seluruh karyawan Perseroan dalam menjalankan kegiatan operasionalnya. Perseroan memastikan tidak melakukan praktik kerja paksa, mempekerjakan pekerja anak/pekerja di bawah umur, buruh migran, dan terlibat dalam perdagangan orang. 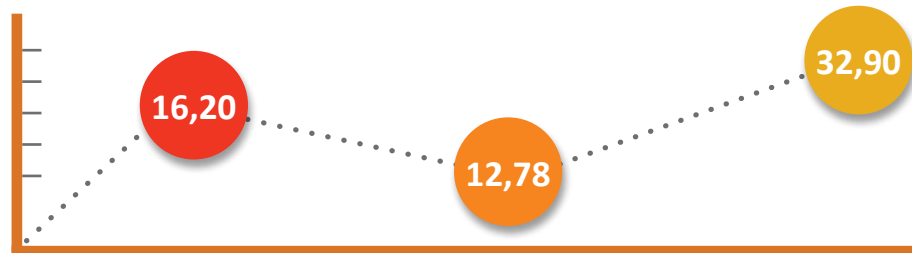

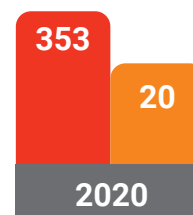
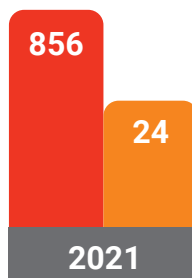


Jumlah dan Rerata Jam Pelatihan berdasarkan Gender Total and Average Training Hours Based on Gender

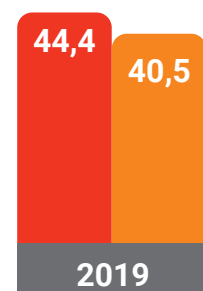
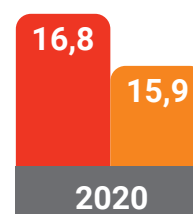

Kewajiban Perseroan atas Program Pensiun Karyawan

The Company's Obligations for the Employee Pension Plans

Perseroan menyelenggarakan program manfaat pasti untuk seluruh karyawan tetap yang berusia 55 tahun ke atas. Pengelolaan dana pensiun dikelola oleh Dana Pensiun Bakrie. Selain itu, Perseroan juga mengikutsertakan karyawan dalam program pensiun melalui BPJS Ketenagakerjaan, yaitu Program Jaminan Hari Tua (JHT) dan Program Jaminan Pensiun (JPP). Untuk program JHT, karyawan setiap bulan berkontribusi sebesar 2% dari gajinya, sedangkan Perseroan berkontribusi sebesar 3,7%. Sementara itu, untuk program JPP, karyawan setiap bulan berkontribusi 1% dari gajinya, sedangkan Perseroan berkontribusi sebesar 2%. Selama tahun 2021, sebanyak 226 karyawan (golongan staf dan non staf) dinyatakan pensiun. Perseroan telah mendistribusikan dana pensiun sebesar Rp 23,5 milyar.

The Company administers an assured benefits program for all permanent employees aged 55 years and older. The management of pension funds is managed by the Dana Pensiun Bakrie. In addition, the Company also enrolls employees in pension programs by BPJS Ketenagakerjaan, namely the Jaminan Hari Tua (JHT) and the Program Jaminan Pensiun (JPP). For the JHT program, employees are contributing 2% of their salary every month, while the Company contributes 3.7%. Meanwhile, for the JPP program, employees are contributing 1% of their salary every month, while the Company contributes 2%. During 2021, 26 employees (staff and non-staff group) were retired. The company has distributed pension funds of IDR23,5 billion.

Perseroan juga memberikan pembekalan kepada karyawan golongan staf yang akan memasuki masa pensiun dengan memberikan pelatihan persiapan pensiun. Selama tahun 2021, pelatihan persiapan pensiun dilakukan oleh Humanis Grup dan Synergi dengan total peserta sebanyak 24 karyawan dengan rincian 11 karyawan pensiun tahun 2021 dan 13 karyawan pensiun tahun 2022.

The company also provides supports to staff class employees who are about to retire by providing retirement preparation trainings. During 2021, retirement preparation trainings were carried out by Humanis Group and Synergi with a total of 24 employees were participating, consisting of 11 employees retiring in 2021 and 13 employees retiring in 2022.

Pemberdayaan Masyarakat [103-1, 103-2, 103-3, 413-1] Community Empowerments

Kegiatan operasional Perseroan banyak berhubungan langsung dengan petani plasma maupun Usaha Mikro, Kecil, dan Menengah (UMKM). Pandemi COVID-19 yang telah berlangsung selama 2 tahun berdampak negatif pada petani plasma dan UMKM karena mereka harus beradaptasi dengan menurunkan produksi barang/jasa, mengurangi jumlah/jam kerja karyawan serta jumlah saluran penjualan/pemasaran. Oleh sebab itu, Perseroan akan memaksimalkan peran dan partisipasi dalam mengelola masalah sosial dan lingkungan dengan mengutamakan pemberdayaan petani, UMKM, dan kelompok rentan lainnya. Program pemberdayaan menjadi tanggung jawab Departemen CSR. Secara berkala Departemen CSR membuat laporan CSR yang dilaporkan kepada Direksi.

Perseroan memiliki program pemberdayaan masyarakat yang terbagi ke dalam program jangka pendek dan jangka panjang. Program pemberdayaan masyarakat jangka pendek meliputi pemetaan potensi dan kebutuhan, perumusan sinergi dan publikasi program secara berkesinambungan. Sementara itu, program pemberdayaan masyarakat jangka panjang memiliki fokus pengembangan pada sembilan bidang, yaitu pendidikan, ekonomi, kesehatan, keagamaan, kepemudaan, lingkungan, infrastruktur, tanggap bencana, serta donasi/publikasi. Perseroan juga ikut serta dalam program Bakrie Infaq Club (Koin Meja) yang dihimpun oleh Yayasan Bakrie Amanah. Selama tahun 2021, Perseroan memanfaatkan dana sebesar Rp 7,36 miliar untuk program pemberdayaan masyarakat (mencakup upstream dan downstream).

The Company's operational activities are dealing directly with smallholders as well as Micro, Small and Medium Enterprises (MSMEs). The COVID-19 pandemic which has been going on for 2 years has had a negative impact on smallholders and MSMEs because they have had to adapt by reducing the production of goods/services, reducing the number/hours of employees working and also the number of sales/marketing channels. Therefore, the Company will maximize its role and participation in managing social and environmental issues by prioritizing the empowerment of farmers, MSMEs and other vulnerable groups. The empowerment programs are the responsibility of the CSR Department. Periodically the CSR Department prepares a CSR report which is then reported to the Board of Directors.

The company organizes community empowerment programs which are divided into short term and long term. Short-term programs include mapping potentials and needs, formulating continual synergies and program publications. Meanwhile, the long-term programs have a development focus on Nine areas, namely education, economy, health, religion, youth, environment, infrastructure, disaster response, and donations/publications. The Company also participates in the Bakrie Infaq Club (Koin Meja) program which is organized by the Yayasan Bakrie Amanah. During 2021, the Company spent IDR 7.36 billion of funds for community empowerment programs (include upstream and downstream).

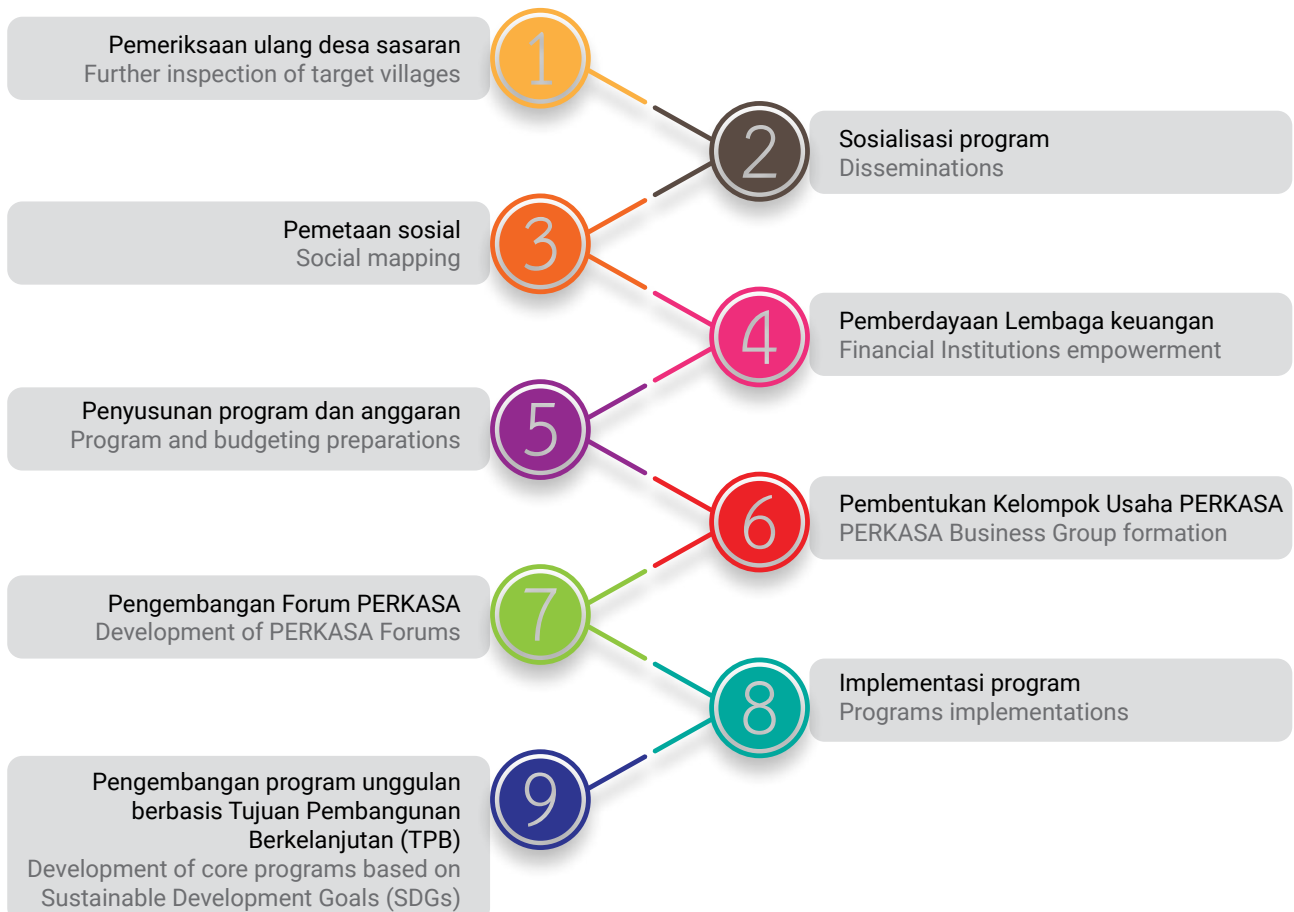

Pendidikan Education



Perseroan mengembangkan yayasan pendidikan di masing-masing Unit Usaha. Hingga akhir tahun 2021, Perseroan telah memiliki 5 yayasan pendidikan, pada Unit Usaha:

- Lampung (HIM), Yayasan Pendidikan Bina Desa, Kabupaten Tulang Bawang. Berdiri sejak tahun 1988.

Di bawah naungan Yayasan Bakrie Pasaman Plantations, pada tahun 2003 didirikan Sekolah Dasar (SD) Bakrie Utama Sungai Aur yang berada di lingkungan Perkebunan Unit Usaha Sumbar (BPP). SD Bakrie Utama Sungai Aur merupakan Sekolah Adiwiyata, yaitu sekolah yang memiliki kurikulum berbasis lingkungan.

Selain itu, Perseroan juga bekerja sama dengan Yayasan Bakrie Amanah memberikan beasiswa dalam program Beasiswa Cerdas untuk Negeri. Penerima beasiswa pada tahun 2021, sebanyak 324 peserta. Perseroan juga menyelenggarakan sekolah gratis dan memberikan apresiasi kepada guru-guru di sekolah yang berada di lingkungan unit usahanya dengan memberikan penghargaan kepada guru teladan. Secara berkala, Perseroan melakukan rehabilitasi dan pengembangan sarana pendidikan dan penunjang. Perseroan mengalokasikan dana untuk program pendidikan sebesar Rp 5,50 miliar.

The Company develops educational foundations at each Business Unit area. Until the end of 2021, the Company has 5 educational foundations, on Business Unit:

- West Sumatra (BPP), Yayasan Pendidikan Bakrie Pasaman Plantations, West Pasaman Regency. Established since 2003.
- Jambi 1 (AGW), Yayasan Pendidikan Putri Ayu, Tungkal Ulu Regency. Established since 2003.
- Sumut 2 (GLP), Yayasan SD Swasta Grahadura Leidongprima, North Labuhanbatu Regency. Established since 2004.
- Jambi 2 (SNP), Yayasan Nusa Cerdas Pertiwi Bakrie, Muaro Jambi Regency. Established since 2012.

Under the auspices of the Yayasan Bakrie Pasaman Plantations, in 2003 the Sekolah Dasar (SD) Bakrie Utama Sungai Alur elementary school was established which is in the vicinity of Perkebunan Unit Usaha Sumbar (BPP). SD Bakrie Utama Sungai Alur is an Adiwiyata School, which is a school with an environment-based curriculum.

In addition, the Company also cooperates with the Yayasan Bakrie Amanah to grant scholarships in the Beasiswa Cerdas Untuk Negeri program. Scholarship awardees in 2021, were 324 participants. The Company also organizes free schools and gives appreciation to teachers at schools within our business units by awarding exemplary teachers. Periodically, the Company carries out rehabilitation and development of educational and supporting facilities. The Company allocates 5.50 billion IDR for educational programs.



Kesehatan Health



Perseroan menyediakan fasilitas kesehatan bagi karyawan maupun masyarakat sekitar antara lain Balai Pengobatan, Pos Pelayanan Terpadu (Posyandu), serta Rumah Sakit Umum Ibu Kartini di Kisaran.

Perseroan mendukung program Pemerintah untuk memutus rantai penyebaran COVID-19 dengan melaksanakan program vaksinasi COVID-19 bagi karyawan dan keluarga, serta masyarakat sekitar di seluruh Unit Usaha. Selama tahun 2021, Perseroan mendistribusikan 3.989 dosis vaksin COVID-19 untuk masyarakat sekitar. Melalui Unit Usaha Sumut 1 (BSP) bekerjasama dengan pemerintah daerah, Perseroan membantu biaya akomodasi kegiatan vaksinasi untuk masyarakat, Perseroan juga memberikan bantuan kepada masyarakat dalam pengamanan pandemi isoman melalui Unit Usaha Jambi 1 (AGW). Sementara itu, melalui Unit Usaha Sumbar (BPP), Perseroan membantu biaya akomodasi dan konsumsi Program Gempur Vaksin.

Selain program pemutusan rantai penyebaran COVID-19, Perseroan juga melakukan program Khitanan Untuk Negeri di 3 Unit Usaha, yaitu Sumut 1 (BSP), Sumut 2 (GLP), dan Jambi 1 (AGW/AMM). Perseroan mengalokasikan dana untuk program kesehatan sebesar Rp 131,68 juta.

The company provides health facilities for employees as well as the surrounding community, including Medical Center, Integrated Service Post (Posyandu), and General Public Hospital Ibu Kartini in Kisaran.

The Company supports the Government's program to break the transmission chain of COVID-19 by organizing vaccination programs for employees and their families, as well as for the surrounding community in all Business Units. During 2021, the Company distributed 3.989 doses of COVID-19 vaccines for the surrounding community. Through the Sumut 1 Business Unit (BSP) in collaboration with the local government, the Company helps with accommodation costs for vaccination activities for the community, the Company also helps the community in protecting the isoman pandemic through Jambi 1 Business Unit (AGW). Meanwhile, through the Sumbar Business Unit (BPP), the Company aids with accommodation and consumption costs for the Gempur Vaksin program.

In addition to the program dealing with COVID-19, the Company also carried out the Khitanan Untuk Negeri program in 3 Business Units, namely Sumut 1 (BSP), Sumut 2 (GLP), and Jambi 1 (AGW/AMM). The company allocates 131.68 million IDR for health programs.



Keagamaan Religions

Perseroan mengalokasikan dana untuk program keagamaan sebesar Rp 569,89 juta. Kegiatan program keagamaan yang dilakukan Perseroan melalui Unit Usaha mencakup:

- Pemberian tali asih ataupun pemberian paket lebaran bagi masyarakat sekitar kebun untuk >4.600 penerima manfaat/kepala keluarga;
- Santunan pelaksanaan acara keagamaan, baik untuk bulan Ramadhan maupun Natal; serta
- Sumbangan tempat ibadah maupun bantuan material untuk perbaikan atau pembangunan tempat ibadah.

The company allocates 569.89 million IDR for religious programs. Religious program activities carried out by the Company through its Business Units which includes:

- Distribution of Eid packages to communities around the plantations for more than 4,600 beneficiaries/families;
- Allowance for religious events, both for Ramadan and Christmas; as well as
- Donations for religious places and assistance in the repair or construction of religious places.



Perseroan mengalokasikan dana untuk program ekonomi sebesar Rp 75,97 juta. Kegiatan program ekonomi yang dilakukan oleh Perseroan antara lain :

Pengembangan UMKM.

Perseroan melakukan pembinaan koperasi dan pengembangan UMKM. Fokus kegiatan ini adalah pembinaan, bantuan sarana dan prasarana kerja, dan bantuan modal kerja. Hingga akhir tahun 2021, tercatat terdapat 23 koperasi binaan di masyarakat, termasuk 8 di antaranya merupakan koperasi karyawan.

Pada tahun 2021, melalui Unit Usaha Jambi 1 (AGW dan AMM), Perseroan mendukung UMKM dengan memberikan bantuan berupa:

- Bantuan pembuatan serbuk jahe merah;
- Bantuan bahan baku pembuatan tempe, tahu, dan pecel;
- Bantuan bibit ikan;
- Bantuan bibit tanaman dan buah;
- Bantuan pupuk organik jangkos untuk tanaman; serta
- Bantuan pengadaan mesin *Robin*.

Program Kemitraan Inti-Plasma

Fokus dari kegiatan kemitraan inti-plasma adalah pemberian kredit modal, pembinaan tata cara berkebun yang profesional dan sesuai standar Perseroan, pembelian hasil kebun pada harga pasar, pelatihan teknis perkebunan serta program studi banding pembuatan bibit sawit.

Perseroan mengembangkan 2 bentuk pola kemitraan plasma, yaitu:

- Perkebunan Inti Rakyat Transmigrasi (PIR-Trans) untuk masyarakat transmigrasi; dan
- Kredit Koperasi Primer Anggota (KKPA) untuk masyarakat lokal yang dihimpun dalam wadah koperasi untuk efektivitas pembinaan.

Program Kemitraan Non-Plasma

Pada tahun 2021, Perseroan telah melakukan beberapa program kemitraan non plasma. Melalui Unit Usaha Lampung (HIM), Perseroan melakukan pelatihan teknis

The company allocates 75.97 million IDR for economic programs. The economic program activities by the Company includes:

MSMEs Development

The company conducts coaching for cooperatives and MSMEs development. The focus of these activities is coaching, assistance with work facilities and infrastructure, and providing working capital assistance. Until the end of 2021, there were 23 fostered cooperatives in the community, including 8 of which were employee cooperatives.

In 2021, through the Jambi 1 Business Unit (AGW and AMM), the Company supported MSMEs by providing assistances in the forms of:

- Red ginger grinding;
- Raw materials for making tempeh, tofu, and pecel;
- Fish seeds;
- Plants and fruits seeds;
- EFB organic fertilizer for plants; and
- Robin engine procurement.

Nucleus-Plasma Partnership Program

The focus of the nucleus-plasma partnership activities is the provision of capital credit, professional and company-standard gardening coaching, the purchase of garden products at market prices, plantation technical training and a comparative study program for making oil palm seeds.

The company developed 2 forms of plasma partnership patterns, namely:

- Perkebunan Inti Rakyat Transmigrasi (PIR-Trans) for transmigrated communities; and
- Kredit Koperasi Primer Anggota (KKPA) for local communities who are within a cooperative for the coaching effectiveness.

Non-Plasma Partnership Program

In 2021, the Company has carried out several non-plasma partnership programs. Through the Lampung (HIM) Business Unit, the Company conducted technical training

on plant cultivations and provided superior seeds to rubber farmer groups. Through the Sumut 1 (BSP) and Sumbar (BPP) Business Units, the Company helps in the process of replanting the community palm land that has passed productive age through the Peremajaan Sawit Rakyat (PSR) program and the non-PSR. The scope of the non-plasma partnership includes helping the provision of superior plant seeds as many as 103,596 seedlings, assistance and training in plantation technical management, assistance in maintenance or infrastructural repair, in providing work tools as well as in monitoring and evaluation.



Kepemudaan Youth

Perseroan mengalokasikan dana untuk program kepemudaan sebesar Rp 122 juta. Kegiatan program kepemudaan yang dilakukan Perseroan antara lain:

Sekolah Sepak Bola (SSB) Bakrie Asahan

Pada tahun 2009 Perseroan mendirikan Sekolah Sepak Bola (SSB) Bakrie Asahan di dekat pabrik Bunut dan Kisaran milik Unit Usaha Sumut 1 (BSP). Pada akhir tahun 2021, tim SSB Bakrie Asahan untuk anak usia di bawah 13 tahun (U-13) menjadi perwakilan dari Sumatera Utara dan memenangi kompetisi *Fosbolindo Junior League* (FJL) tingkat nasional. Dua pemain dari tim SSB juga memperoleh penghargaan sebagai kipper dan pemain terbaik.

Pramuka Gugus Depan (Gudep) 007-008

Perseroan mengembangkan kegiatan pramuka tingkat penggalang melalui Gugus Depan (Gudep) 007-008 di pabrik karet Sumut 1 (BSP). Kegiatan ini menggalang anak-anak usia 11-17 tahun dengan total peserta sebesar 35 peserta. Sebanyak 75% peserta merupakan anak karyawan dan 25% merupakan anak masyarakat sekitar pabrik. Sementara itu, untuk pembina pramuka, 50% merupakan karyawan dan 50% guru SD setempat.

Pembinaan Karang Taruna/Kepemudaan

Melalui Unit Usaha Sumbar (BPP), Perseroan melakukan pembinaan karang taruna/kepemudaan dengan fokus kegiatan berupa sosialisasi bahaya narkoba serta pengadaan sarana dan prasarana olah raga.

The company allocates IDR 122 million for youth programs. Youth program activities carried out by the Company including:

Bakrie Asahan Football School (SSB)

In 2009, the Company established a Sekolah Sepak Bola (SSB) Bakrie Asahan near the Bunut and Kisaran factories belonging to the Sumut 1 Business Unit (BSP). At the end of 2021, the SSB Bakrie Asahan team for children under 13 years old (U-13) became the representative team of Sumatra Utara and won the national-level Fosbolindo Junior League (FJL) competition. Two players from the SSB team also won the awards for the best goalkeeper and player.

Scouting Gugus Depan (Gudep) 007-008

The company organizes scouting level activities through Gugus Depan (Gudep) 007-008 at the Sumut 1 (BSP) rubber factory. This activity invited children aged 11-17 years with a total of 35 participants. As many as 75% of the participants were employees' children and 25% were of the locals. Meanwhile, for scout coaches, 50% are employees and 50% are local elementary school teachers.

Karang Taruna / Youth Development

Through the West Sumatra Business Unit (BPP), the Company conducts youth/youth coaching with a focus on activities in the form of socializing the dangers of drugs and procuring sports facilities and infrastructure.



Lingkungan Environment



Perseroan mengalokasikan dana untuk program lingkungan sebesar Rp 29,5 juta. Pada tahun 2021, kegiatan program lingkungan yang dilakukan Perseroan adalah

- Normalisasi parit aliran sungai sekitar kebun Bunut dan pengembangan kawasan wisata *mangrove* pada Unit Usaha Sumut 1 (BSP);
- Bantuan 2.000 bibit ikan gurami dan 6.000 bibit lele untuk dilepas di sungai pada Unit Usaha Jambi 1 (AGW/AMM) dalam rangka memperingati Hari Lingkungan Hidup Sedunia;
- Bantuan dana pembelian bibit buah-buahan; dan
- Pelestarian air dan lingkungan di sekitar Unit Usaha Jambi 2 (SNP).

The company allocates IDR 29.5 million for environmental programs. In 2021, the environmental program activities carried out by the Company were:

- Normalization of river flow ditches around the Bunut plantation and development of a mangrove tourism area at the Sumut 1 Business Unit (BSP);
- Assistance of 2,000 carp seeds and 6,000 catfish seeds to be released into the river at the Jambi Business Unit 1 (AGW/AMM) in celebration of the World Environment Day;
- Funding for the purchase of fruit seeds; and
- Conservation of water and the environment around the Jambi 2 Business Unit (SNP).



Infrastruktur Infrastructures



Perseroan mengalokasikan dana untuk program infrastruktur sebesar Rp 216,86 juta. Pada tahun 2021, kegiatan program infrastruktur yang dilakukan Perseroan antara lain:

- Perbaikan jaringan jalan dan jembatan di Unit Usaha Sumut 2 (GLP) dan Jambi 2 (SNP);
- Melalui Unit Usaha Sumbar (CCI), memberikan bantuan pembuatan dan perbaikan jalan obyek wisata Telun Berasap di Nagari Bukit Buai Tapan, Sumatra Barat; serta
- Melalui Unit Usaha Bengkulu (AM), berpartisipasi dalam pengerasan lahan parkir Desa Suka Makmur, Marga Sakti Sebelat, Bengkulu Utara.

The company allocates IDR 216.86 million for infrastructure programs. In 2021, the Company's infrastructure program activities were:

- Repaired road networks and bridges in the Sumut 2 (GLP) and Jambi 2 (SNP) Business Units;
- Through the Sumbar Business Unit (CCI), assisted the construction and repair of roads for the Telun Berasap tourist attraction in Nagari Bukit Buai Tapan, West Sumatra; as well as
- Through the Bengkulu Business Unit (AM), contributed in paving the parking lot for Suka Makmur Village, Marga Sakti Sebelat, North Bengkulu.



Tanggap Bencana Disaster Response

Perseroan mengalokasikan dana untuk program tanggap bencana sebesar Rp118,45 juta. Pada tahun 2021, Perseroan melakukan program tanggap bencana berupa:

- Program Rendang Kaleng dari Qurban untuk Negeri, merupakan program penyaluran makanan siap saji kornet rendang sapi untuk masyarakat korban erupsi Gunung Semeru serta penyintas COVID-19 di sekitar Unit Usaha;
- Penyaluran dana tanggap bencana melalui Unit Usaha Kalsel (MIB), Jambi 1 (AGW/AMM), dan Sumbar (CCI) untuk korban bencana banjir di sekitar Unit Usaha; dan
- Melalui Unit Usaha Sumbar (CCI), melakukan penyaluran bantuan sosial untuk lansia yang terdampak COVID-19.

The company allocated IDR118.45 million for disaster response programs. In 2021, the Company carried out disaster response programs in the forms of:

- The Canned Rendang program from Qurban Untuk Negeri, is a program of distributing ready-to-eat corned beef rendang for victims of the Mount Semeru eruption and COVID-19 survivors around Business Units;
- Distribution of disaster response funds through the Kalsel Business Unit (MIB), Jambi 1 (AGW/AMM), and Sumbar (CCI) for flood victims around the Business Units; and
- Through the Sumbar Business Unit (CCI), distributing social assistance to the elderlies affected by COVID-19.



Donasi/Publikasi Donations/Publications

Perseroan mengalokasikan dana untuk program donasi/publikasi sebesar Rp473,41 juta. Pada tahun 2021, dana ini digunakan untuk:

- Pembangunan daerah tempatan maupun bantuan dana partisipasi berbagai proposal/kegiatan di lingkungan masyarakat sekitar pabrik dan kebun di Unit Usaha Sumut 2 (GLP), Jambi 1 (AGW/AMM), dan Sumbar (BPP); serta
- Bantuan dana untuk melakukan sinergi kegiatan CSR dengan Pemerintah Daerah di Unit Usaha Sumbar (BPP).

The company allocated IDR473.41 million for donation/publication programs. In 2021, these funds were utilized for:

- Development of the local area as well as funding assistance in participation of various proposals/activities within the communities around the factories and plantations at the Sumut 2 (GLP), Jambi 1 (AGW/AMM) and Sumbar (BPP) Business Units;
- Funding assistance to synergize CSR activities with the Regional Government in the Sumbar Business Unit (BPP).



Mekanisme Pengaduan Masyarakat/Lingkungan Masyarakat^[413-1] Complaint Mechanism for the Community/Environment



Perseroan memberikan akses kepada masyarakat maupun pemangku kepentingan lainnya terkait dampak kegiatan operasional dan tanggung jawab lingkungan yang diterapkan melalui kotak pengaduan dan email. Laporan pengaduan beserta dengan bukti pendukung yang masuk akan diproses dan dikaji oleh Unit Penanganan Keluhan (UPK). Kemudian, Tim Verifikasi akan melakukan verifikasi lapangan jika terdapat bukti yang cukup. Hasil dari verifikasi lapangan akan dilaporkan langsung ke Direksi. Selanjutnya, Direksi akan mengambil keputusan tindak lanjut berdasarkan laporan hasil verifikasi lapangan yang diserahkan ke unit terkait. Selama tahun 2021, Perseroan tidak menerima pengaduan keluhan dari masyarakat terkait aspek sosial maupun lingkungan.

The company provides access to the public and other stakeholders regarding the impact of operational activities and environmental responsibility which is implemented via a complaint box and email. Complaint reports along with supporting evidence will be processed and reviewed by the Complaint Handling Unit. Then, the Verification Team will conduct field verification for sufficient evidence. The results of the field verification will be reported directly to the Board of Directors. Afterwards, the Board of Directors will make a follow-up decision based on the field verification report submitted to the relevant unit. During 2021, the Company did not receive any complaints from the public regarding social and environmental aspects.

Biodiversity

Hingga akhir tahun 2021, Perseroan mengelola lahan seluas 67.714 Ha untuk perkebunan sawit dan karet. Terlepas dari kegiatan utama bisnis, Perseroan memiliki komitmen untuk menjaga keanekaragaman hayati di lokasi operasi, dengan mengalokasikan lahan seluas 63,45 Ha sebagai area konservasi flora dan fauna langka, penyerapan air, serta untuk kepentingan pendidikan. Area konservasi tersebut berada di Unit Usaha Sumbar (BPP), Sumut 1 (BSP), dan Jambi 1 (AGW) dengan masing-masing luas area konservasi sebesar 30 Ha, 19,10 Ha, dan 14,35 Ha. Perseroan bekerja sama dengan Dinas Kehutanan untuk mengelola area konservasi tersebut. Program perlindungan keanekaragaman hayati menjadi tanggung jawab Departemen QHSE & Sustainability. Secara berkala Departemen QHSE & Sustainability membuat laporan kegiatan yang dilaporkan kepada Direksi.

Until the end of 2021, the Company manages 67,714 Ha of land for oil palm and rubber plantations. Apart from the main business activities, the Company is committed to maintaining biodiversity in its operating locations, by allocating 63.45 Ha of land as a conservation area for rare floras and faunas, water absorptions, as well as for educational purposes. The conservation areas are located in the Sumbar (BPP), Sumut 1 (BSP), and Jambi (AGW) Business Units with a conservation area of 30 Ha, 19.10 Ha and 14.35 Ha respectively. The company cooperates with the Forestry Agency to manage the conservation area. The biodiversity protection program is the responsibility of the QHSE & Sustainability Department. Periodically the QHSE & Sustainability Department prepares activity reports which are then reported to the Board of Directors.

Pada tahun 2021, Perseroan telah melakukan Penilaian Kembali (*re-assessment*) atas kawasan dengan Nilai Konservasi Tinggi (NKT)/Stok Karbon Tinggi (SKT) dalam rangka pemutakhiran proses identifikasi keanekaragaman hayati yang dikelola Perseroan dan pemenuhan standar sertifikasi keberlanjutan (ISPO dan RSPO). Secara berkala, Perseroan juga melakukan pemantauan terhadap jenis flora dan fauna yang dilindungi yang terkena dampak kegiatan operasional Perseroan. ^[304-1, 304-4]

In 2021, the Company has carried out a re-assessment of areas with High Conservation Value (HCV)/High Carbon Stock (HCS) in order to update the process of identifying biodiversity managed by the Company and fulfilling sustainability certification standards (ISPO and RSPO). Periodically, the Company also monitors the types of protected flora and fauna affected by the Company's operational activities. ^[304-1, 304-4]

Miniatur Hutan Konservasi [304-3]

Sejak tahun 2011 Perseroan mengembangkan Miniatur Hutan Konservasi di Unit Usaha Jambi 1 (AGW). Miniatur Hutan Konservasi ini berlokasi di tengah perkebunan sawit dengan luas 17 Ha, dan berada dekat dengan lingkungan masyarakat. Miniatur Hutan Konservasi bertujuan untuk menjaga dan mengembangkan keanekaragaman hayati dan mengelola ekosistem sekitarnya. Selain itu, Miniatur Hutan Konservasi juga menjadi area resapan air, area yang memproduksi O₂ dan menyerap CO₂, sumber makanan hewan, serta sebagai area wisata bagi masyarakat dan karyawan.

Hutan Vegetasi [304-3]

Sejak tahun 2011, melalui Unit Usaha Jambi 1 (AGW), Perseroan mengembangkan kawasan hutan vegetasi di beberapa lokasi kebun. Hutan vegetasi ini bertujuan untuk mempertahankan kelestarian lingkungan khususnya habitat hewan dan tumbuhan, sebagai upaya untuk mengembalikan dan meningkatkan kualitas lingkungan, serta memperbaiki keseimbangan ekosistem. Hutan vegetasi dan habitat yang ada di dalamnya berjalan secara alami. Perseroan tidak melakukan pemantauan khusus terhadap habitat hewan dan tumbuhan yang ada di kawasan hutan vegetasi.

Pengelolaan Lahan Gambut

Dalam pengelolaan lahan gambut, Perseroan senantiasa menerapkan praktek-praktek terbaik berdasarkan peraturan perundangan yang berlaku termasuk melakukan kerjasama dengan para ahli dalam melakukan kajian dan mendapatkan masukan terbaik dalam pengelolaan lahan gambut. Perseroan juga aktif melakukan pembinaan kepada desa-desa di sekitar anak usaha untuk menjadi desa yang peduli terhadap pengelolaan gambut dalam rangka mencegah terjadinya kebakaran hutan dan lahan (karhutla). Diantara praktek terbaik pengelolaan gambut yang dilakukan Perseroan antara lain optimalisasi tata Kelola air (*water management*) dalam rangka menjaga Tinggi Muka Air Tanah (TMAT) sesuai kondisi optimal (40 cm dibawah permukaan tanah), pemantauan berkala TMAT (manual dan logger) dan penurunan lahan gambut (subsidence).

Miniature Conservation Forest [304-3]

Since 2011 the Company has developed a Miniature Conservation Forest in the Jambi 1 (AGW) Business Unit. This Miniature Conservation Forest is located in the middle of a palm plantation with an area of 17 Ha and is close to the community environment. Miniature Conservation Forest aims to maintain and develop biodiversity and manage the surrounding ecosystem. Apart from that, the Miniature Conservation Forest is also a water absorption area, an area that produces O₂ and absorbs CO₂, a source of food for animals, as well as a tourism area for the community and employees.

Vegetation Forest [304-3]

Since 2011, through the Jambi 1 (AGW) Business Unit, the Company has developed vegetation forest areas in several plantation locations. This vegetation forest aims to maintain environmental sustainability, especially animal and plant habitats, as an effort to restore and improve environment quality, as well as to improve ecosystem balance. Forest vegetation and the habitats within are functioning naturally. The company does not carry out special monitoring of animals and plant habitats in the vegetation forest area.

Peatland Management

In managing peatlands, the Company always applies best practices based on applicable laws and regulations, including collaborating with experts in conducting studies and obtaining the best input on peatland management. The company is also actively provides guidance to villages around its subsidiaries to become villages that care about peat management in order to prevent forest and land fires (karhutla). Among the best practices in peat management carried out by the Company were optimizing water management in order to maintain the Ground Water Level according to optimal conditions (40 cm below the ground surface), periodic monitoring of Ground Water Level (manual and logger) and peat land subsidence.

Pencegahan Kebakaran Hutan dan Lahan (Karhutla)

Perseroan berkomitmen dalam mencegah kebakaran hutan dan lahan (karhutla) dengan mengembangkan dan memperkuat sistem pencegahan dan penanggulangan Karhutla. Pengendalian yang sudah dilakukan Perseroan antara lain:

- Kerjasama multipihak untuk memperkuat kolaborasi dalam mengimplementasikan program-program pencegahan kebakaran
- Pemasangan alat peraga peringatan dini
- Identifikasi dan pemetaan areal areal yang rawan kebakaran
- Patroli terintegrasi dan pengamatan insiden kebakaran oleh tim patroli kebakaran;
- Pelatihan pencegahan kebakaran secara rutin, khususnya di area perkebunan yang berisiko tinggi;
- pemantauan cuaca dan titik panas berdasarkan data dari satelit
- Pemeliharaan sarana dan prasarana pencegahan kebakaran.
- Pembangunan menara pemantauan kebakaran.
- Pemetaan sumber-sumber air.
- Pengamanan kebakaran dan komunikasi rutin kepada pemangku kepentingan utama mengenai Kebijakan Keberlanjutan Perseroan, khususnya terkait larangan pembakaran lahan.

Forest and Land Fires (Karhutla) Prevention

The Company is committed to preventing forest and land fires (karhutla) by developing and strengthening a Karhutla prevention and control system. The actions that have been carried out by the Company include:

- Multi-parties cooperation to strengthen collaboration in implementing fire prevention programs;
- Installation of early warning props;
- Identification and mapping of fire-prone areas;
- Integrated patrol and observation of fire incidents by the fire patrol team;
- Regular fire prevention training, especially in high risk plantation areas;
- Weather monitoring and hot spots based on data from satellites;
- Maintenance of fire fighting apparatus;
- Construction of fire monitoring towers;
- Water sources mapping;
- Fire safety measures and routine communication to key stakeholders concerning the Company's Sustainability Policy, particularly regarding the prohibition of land burning.

Pengendalian Hama ^[304-2]

Pest Control

Perseroan mengendalikan hama perkebunan secara biologis untuk mendukung upayanya dalam mengurangi penggunaan paraquat dan pestisida lainnya. Pengendalian secara biologis atau yang disebut juga dengan pengendalian hayati dilakukan dengan cara memanfaatkan tanaman bunga pukul delapan (*Turnera ulmifolia* dan *Turnera subulate*) sebagai inang bagi serangga pemangsa hama Ulat Api (*Setothosea asigna*), serta penangkaran Burung Hantu (*Tyto alba*) sebagai pemangsa hama tikus.

The Company controls plantation pests biologically to support its efforts in reducing the use of paraquat and other pesticides. Biological control is carried out by utilizing bunga pukul delapan plants (*Turnera ulmifolia* and *Turnera subulate*) as hosts for caterpillar pest predators (*Setothosea asigna*), as well as owls (*Tyto alba*) as rat predators.

Emission

Perseroan membutuhkan energi seperti BBM dan listrik untuk kegiatan operasionalnya. Dari penggunaan energi tersebut, Perseroan menghasilkan emisi Gas Rumah Kaca (GRK). Salah satu faktor utama pemanasan global adalah emisi GRK. Perseroan berkomitmen untuk melakukan pengendalian emisi dan turut berkontribusi dalam upaya bersama penanganan perubahan iklim. Pengendalian emisi menjadi tanggung jawab Departemen Operasional (kebun dan pabrik) yang dikoordinasikan oleh Departemen QHSE & Sustainability. Secara berkala, kinerja pengendalian emisi dipantau dan dilaporkan kepada Direksi dan pihak-pihak berwenang.

Pengendalian emisi yang dilakukan Perseroan dengan melakukan beberapa kegiatan yang bersifat pencegahan antara lain: inventarisasi sumber emisi, sosialisasi upaya-upaya pengurangan emisi, efisiensi penggunaan material sumber emisi dan perhitungan emisi GRK. Perseroan melakukan inventarisasi emisi mengacu pada perhitungan emisi GRK berdasarkan standar RSPO dan ISPO dengan satuan Ton CO₂ ekuivalen (Ton CO₂eq). Sumber emisi GRK yang dihasilkan oleh Perseroan berasal dari kegiatan operasional di kebun maupun pabrik.

The Company requires energy such as fuel and electricity for its operational activities. From this energy use, BSP generates greenhouse gas (GHG) emissions. One of the main factors of global warming is GHG emissions. The Company is committed to controlling emissions and contributing to joint efforts to address climate change. Emission control is the responsibility of the Operational Department (plantations and mills, which is coordinated by the QHSE & Sustainability Department. Periodically, emission control performance is monitored and reported to the Board of Directors and the authorities.

The emission control carried out by the Company is by carrying out several preventative activities including: inventory of emission sources, socialization of emission reduction efforts, efficient use of emission source materials and calculation of GHG emissions. The company conducts an emission inventory referring to the calculation of GHG emissions based on the RSPO and ISPO standard emission calculations in Ton CO₂ equivalent (Ton CO₂eq). The source of GHG emissions produced by the Company comes from operational activities in plantations and plants.

Energy

Perseroan membutuhkan energi seperti listrik dan BBM untuk menjalankan kegiatan operasionalnya. Energi yang dibutuhkan antara lain untuk pengangkutan bahan mentah dan proses produksi.

Upaya yang dilakukan Perseroan untuk mengurangi konsumsi energi adalah dengan:

- Menggunakan sumber energi alternatif biomassa sebagai bahan bakar boiler;

Program konservasi energi menjadi tanggung jawab Departemen Operasional (kebun dan pabrik) yang dikoordinasikan oleh Departemen QHSE & Sustainability. Semua Unit Usaha melakukan program konservasi energi. Secara berkala, program konservasi energi di semua Unit Usaha diaudit oleh lembaga sertifikasi terkait melalui kegiatan pemeriksaan lapangan.

The company needs energy such as electricity and fuel to carry out its operational activities. The energy needed, among others, is for the transportation of raw materials and production processes.

Efforts made by the Company to reduce energy consumption includes the following:

- Boiler modification from SFPO type to membrane type with a higher efficiency level;
- Utilizing alternative energy sources of biomass as boiler fuel;

The energy conservation program is the responsibility of the Operational Department (plantations and mills), which is coordinated by the QHSE & Sustainability Department. All Business Units carry out energy conservation programs. Periodically, the energy conservation program in all Business Units is audited by the relevant certification body through on-site assessments.

Sejak tahun 2008, Perseroan telah mengembangkan *biomassa*. Selain sebagai komitmen Perseroan untuk memanfaatkan energi terbarukan, *biomassa* juga merupakan komitmen Perseroan untuk meningkatkan pemakaian material ramah lingkungan dengan mengolah cangkang dan *fiber* menjadi bahan bakar *boiler*. Pada tahun 2021, konsumsi energi yang digunakan dari biomassa adalah sebesar 12.398 kWh. Since 2008, the Company has been developing biomasses. Aside from being the Company's commitment to utilizing renewable energy, biomass is also the Company's commitment to increase the use of environmentally friendly materials for example by processing shells and fiber into boiler fuel. In 2021, the energy consumption from biomass was 12,398 kWh.



Air dan Efluen [103-1, 103-2, 103-3]

Water and Effluent

Perseroan membutuhkan air untuk kegiatan operasionalnya, baik di pabrik maupun di perkebunan. Sumber air yang digunakan berasal dari air tanah dan air permukaan. Pada perkebunan sawit, Perseroan menerapkan penggunaan parit, baik parit buatan maupun alami. Perseroan menggunakan parit untuk menjaga kelembaban tanah pada lahan gambut dengan perbandingan 1 parit untuk setiap 4 baris tanaman sawit. Secara berkala, Perseroan akan melakukan pengawasan ketinggian air dalam parit sehingga kebutuhan air tanaman sawit tetap terjaga, yaitu dapat digunakan sebagai penampung air saat musim hujan dan sebagai cadangan air *slow release* saat musim kemarau.

Upaya efisiensi penggunaan air yang dilakukan Perseroan antara lain:

- Sosialisasi rutin kepada karyawan terkait pentingnya penggunaan air yang efisien;
- Pemantauan tingkat efisiensi penggunaan air;
- Melakukan perawatan instalasi air;
- Melakukan perbaikan instalasi air jika terjadi kebocoran;
- Menjaga daerah tangkapan air di dalam wilayah operasional dengan melakukan penghijauan sepanjang daerah aliran sungai;

Selain efisiensi air, Perseroan juga memanfaatkan hasil daur ulang olahan limbah cair yang dikelola dalam kolam Instalasi Pengolahan Air Limbah (IPAL) untuk pemenuhan kebutuhan air. Perseroan telah dilengkapi dengan kolam Instalasi Pengolahan Air Limbah (IPAL). Perseroan

The company needs water for its operational activities, both in factories and plantations. The source of water used comes from ground water and surface water. The Company uses surface water for the process of cleaning work tools. Meanwhile, groundwater is used by the Company for the production process. The company strives to manage water efficiently, limiting water use, used water management, and its disposal process. Water management is the responsibility of the Plantations and Mills Department, which is coordinated by the QHSE & Sustainability Department. Evaluation and monitoring of waste management performance is carried out periodically and reported to the Board of Directors. [303-1]

In palm oil plantations, the Company implements the use of ditches, both man-made and natural ditches. The company uses ditches to maintain soil moisture on peatlands with a ratio of 1 ditch for every 4 rows of oil palm trees. Periodically, the Company will monitor the water level in the ditches so that the water needs of the plants are maintained, which can also be used as a water reservoir during the rainy season and as a slow release water reserve during the dry season.

Water usage efficiency efforts by the Company include:

- Routine dissemination to employees concerning the importance of efficient water usage;
- Monitoring the efficiency level of water usage;
- Performing water installation maintenance;
- Carrying out repairs to water installations in the event of a leakage;
- Maintain the water catchment area within the operational area by carrying out reforestation along the watershed.;

In addition to water efficiency, the Company also utilizing the results of recycled processed liquid waste that is managed in a Wastewater Treatment Plant (WWTP) pool to meet water needs. The Company has 6 processing ponds in the Sumut 1 (BSP), 7 processing ponds in the Sumbar

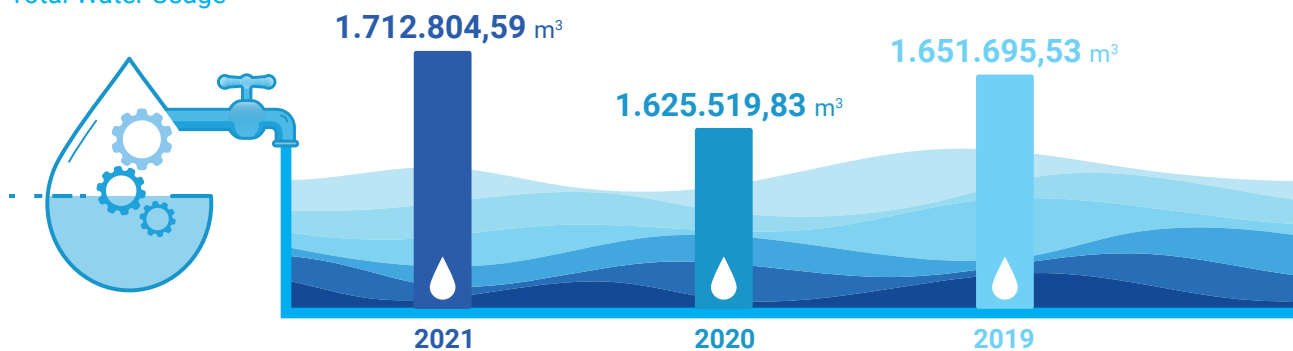

Water Usage

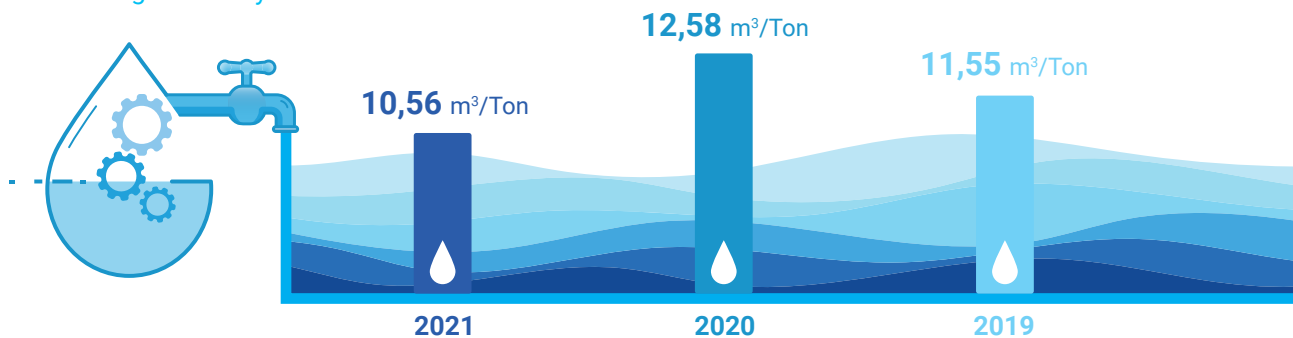
Total Pemakaian Air

Perseroan memanfaatkan limbah padat, yaitu: [306-2]

- Cangkang dan serat menjadi sumber energi alternatif untuk bahan bakar boiler, sebagai mulsa dan pembibitan kelapa sawit, serta sebagai material konstruksi pengerasan jalan sekita wilayah usaha.
- Tandan kosong untuk kompos dan penghambat pertumbuhan gulma.

Sementara itu, untuk limbah cair dimanfaatkan Perseroan sebagai bahan pupuk organik untuk meningkatkan produksi Tandan Buah Segar (TBS). Pengelolaan limbah cair menggunakan sistem *anaerobic* yang selanjutnya akan dimanfaatkan melalui sistem *land application*. [306-2]

Limbah B3 yang dihasilkan Perseroan berupa pelumas (oli) bekas dari proses produksi dalam jumlah yang signifikan yang berasal dari mesin genset, turbin, kendaraan bermotor, *gear box* mesin-mesin produksi dan aktivitas bengkel. Selain itu, limbah B3 yang dihasilkan Perseroan berupa aki bekas, filter oli bekas, lampu neon/merkuri, toner bekas, kain maupun bekas dan kemasan bahan kimia yang digunakan dalam operasional perkebunan. Tahapan pengelolaan limbah B3 Perseroan antara lain: [306-2]

- Meminta izin penyimpanan sementara limbah B3 yang dikeluarkan oleh Kementerian Lingkungan Hidup dan Kehutanan (KLHK) di Jakarta yang berlaku selama 5 tahun.
- Menyimpan limbah B3 selama 180-365 hari sesuai Peraturan Pemerintah yang berlaku.
- Mengirim seluruh limbah B3 ke tempat pengumpulan dan pemusnahan limbah B3 yang sudah mempunyai izin dari Kementerian Lingkungan Hidup dan Kehutanan (KLHK).

Perseroan berkomitmen untuk memantau penggunaan limbah, khususnya B3, mulai dari proses pengangkutan dari rantai pasokan, penyimpanan di gudang, penggunaan, hingga pengelolaan bekas pakai. Selama tahun 2021, tidak terdapat tumpahan limbah B3.

The Company utilizes solid waste, for instances: [306-2]

- Shells and fibers as an alternative energy source for boiler fuel, as mulch and oil palm nurseries, as well as road paving construction materials around the business area.
- Empty bunches for compost and weed growth inhibitors.

Meanwhile, liquid waste is utilized as an organic fertilizer to increase Fresh Fruit Bunches (FFB) production. Liquid waste management uses an anaerobic system which will then be utilized through a land application system. [306-2]

The hazardous waste generated by the Company is in the form of used lubricants (oil) from the production process in significant quantities originating from generator engines, turbines, vehicles, gear boxes of production machines and workshop activities. In addition, the hazardous waste produced by the Company is also in the form of used batteries, used oil filters, neon/mercury lamps, used toner, used cloth and chemicals and their packaging used in plantation operations. Stages of the Company's hazardous waste management, are the following: [306-2]

- Request a permit for temporary storage of hazardous waste issued by Minister of Environment and Forestry in Jakarta which is valid for 5 years;
- Store hazardous waste for 180-365 days in accordance with applicable government regulations;
- Transport all hazardous waste to a hazardous waste collection and destruction site as permitted by the Ministry of Environment and Forestry.

The company is committed to monitor the use of waste, especially hazardous, starting from the transportation process at the suppliers chain, storage in warehouses, utilization, up to the after use management. During 2021, there were no hazardous waste spills.
